

Rules on letting this property


Properties can be rented if they have an energy rating from A to E.

Low and zero carbon energy sources

Primary energy use

The primary energy use for this property per year is 269 kilowatt hours per square metre (kWh/m2).

Environmental impact of this property

One of the biggest contributors to climate change is carbon dioxide (CO2). The energy used for heating, lighting and power in our homes produces over a quarter of the UK's CO2 emissions.
