Paygate Bungalow is an individual, detached, single storey, period cottage presenting mixed elevations of white painted weather boarding and rendering beneath a pitched and hipped tiled roof. The neatly presented character accommodation briefly comprises a sitting-room/dining room with fireplace housing a wood-burning stove and an aspect to front. The kitchen is fitted with base level units including a single bowl stainless steel sink unit, space and plumbing for washing machine, space and electric point for cooker and fridge with a pleasant aspect to rear. The two bedrooms comprise a double and a single room served by a wet room fitted with a white suite and ceiling height tiling.

Outside, a wrought iron gate and pathway lead round to the rear of the cottage, to a lawned garden incorporating established shrubs and hedging. A five bar gate provides access to the land which comprises two grass paddocks, bordered by established hedging. Within the boundary and just on down from the cottage is an overgrown pond. Fine views are enjoyed out across to the North Downs from the land.

Continue on, turning right at the staggered crossroads into North Road (B2079). Continue on, passing the grass triangle island and on past Ladysden Farm, on the left. Continue up the hill and Paygate Bungalow will been seen ahead of you, set off the left-hand bend. Turn right and the five bar gated entrance into the paddock will be clearly seen on the left.
