An attractive block of mixed deciduous and some coniferous woodland forming part of Robingate Wood, on the outskirts of Royal Tunbridge Wells. In all some 8.08 acres (3.27 hectares).

**DESCRIPTION:** The woodland at Blackhurst Lane comprises an attractive block of deciduous and some coniferous woodland, with a mixture of mature standards interspersed with naturally regenerating woodland, predominantly Hemlock. In all the woodland extends to 8.08 acres (3.27 hectares).

The woodland is designated as Ancient & Semi-Natural Woodland, and is subject to Tree Preservation Orders (009/2013 and 005/1962). There are no public rights of way passing through the land, however the woodland is used informally by locals to pass through to Robingate Wood to the north.


**TENURE:** The land is offered freehold with Vacant Possession.



**RESTRICTIVE COVENANTS:** The land will be sold subject to restrictive covenants to prevent future fragmentation of the woodland and to prevent any use that may be considered a nuisance to neighbouring landowners. Further details are available on request from the selling agent.

**SERVICES:** The land is not connected to any services. Applicants are required to make their own investigations as to the possibility of local service connections.

**ACCESS:** The woodland can be accessed along Blackhurst Road via two pedestrian gates.



**METHOD OF SALE:** The land is offered for sale by Private Treaty. The selling agents may set a deadline for Best and Final Offers in the event that significant interest is received.

**DIRECTIONS:** From the exit of the A21 Pembury Bypass, head west along Pembury Road and follow for 0.7 miles, before turning right at the crossroads onto Blackhurst Lane. Continue for 0.8 and the woodland will be located on the left hand side, with approximately 205m of road frontage.

**MINERAL**, **SPORTS AND TIMBER RIGHTS:** Included in the freehold sale, with the exception of shooting rights which are excluded.
